Please could you make sure that the Schools Safeguarding Team has up to date contact information for the DSLs in your setting. This is particularly important for our colleagues in Operation Encompass as 'undeliverable emails' mean that children and young people are not getting the support they need following domestic abuse incidents in their homes.

If a DSL in your setting has left, is on leave or has changed their name/email address, please let us know as soon as possible. That way, we can ensure the correct information is getting to the correct people without any delays.

### Notifying Parents/Carers

All schools in Northumberland are Operation Encompass and Operation Endeavour schools and you must notify parents of this. The end of this term and beginning of the new academic year are both good times to remind parents, and it's especially important that new parents/carers are notified. The template letters have recently been updated and are available for you to cut and paste from the **DSL in Schools and APs SharePoint** site, in the Operation Encompass and Endeavour folder. You can also add the letters and logos to your school website.



**There is an up-to-date list of DASV support services available in the DASV folder on the DSL in Schools' and APs' SharePoint site, please share this information with parents and carers via your website, newsletters and through signage in schools. DASV incidents rise during school holidays so it's helpful for families to have this information before you break up for summer.**



## Supporting attendance when schools return

We know some pupils may find it challenging to return to school after the summer holidays and this will be a key focus for you – take a look at the [information and guidance to help you support pupil attendance](#). ## DSL Holiday Cover



The Schools Safeguarding Team has put a DSL Holiday Cover Template on the DSL in Schools and APs SharePoint Site, **in the Operation Encompass and Operation Endeavour folder**, and there is also a copy of the template attached to the email containing this issue of Safe To Learn. It would be very helpful to Children's Services, if you could allocate cover over the school summer holidays and complete the template, please.

This will enable Children's Services to contact the appropriate person from your school in an emergency, or to let you know if there is going to be an Initial Child Protection Conference for a child in your school, should you wish to attend or send important information. ## RSE and RHE Delivery

The Schools Safeguarding Team have recently been alerted to the fact that a number of organisations are contacting schools offering to deliver Relationship and Sex Education and Relationship and Health Education, some of which are not offering a balanced and appropriate curriculum to children and young people. If you are considering using any visiting organisations to deliver content from the RSE and RHE curriculum to your students, please ensure that any organisations you choose to use are delivering balanced and appropriate views to your students and that this is in line with your Relationship and Sex Education Policy, and in line with KCSiE 2021/2022. Particular attention should be given to KCSiE 2022 paragraphs 202 – 204



**Paragraph 204:** *LGBT inclusion is part of the statutory Relationships Education, Relationship and Sex Education and Health Education curriculum and there is a range of support available to help schools counter homophobic, biphobic and transphobic bullying and abuse.*

Risks can be compounded where children who are LGBT lack a trusted adult with whom they can be open. If schools invite visiting organisations into school, which profess ideas that would make it difficult for a child to seek the support of a trusted adult in school, they are putting that child at risk and are not fulfilling their safeguarding duty to that child.
