# Important Information Regarding a Tik Tok Video



It has been brought to our attention, by our safeguarding partners that there is a concerning video going around on TIK TOK regarding 24th April 2023 being an alleged Rape Day. This has been shared multiple times around social media and apparently it has been created as a video for people to participate in, like previous examples such as the blackout dares (ligature videos). It started in 2021 and is trending again. The trend is called April 24<sup>th</sup>. There is a lot of

counter-information, but it is something that young people could be influenced by, and it is important that we acknowledge that many young people, even those who should not be accessing TikTok, may become aware of this trend.

We are not suggesting that you bring this specific video to the attention of your pupils, as we know that may make them inquisitive, but please ensure you are reminding pupils and parents about safe internet use.

# Northumberland Children and Adult's Safeguarding Partnership (NCASP) Updates

### **Review of NCASP Partnership arrangements**



Following a period of consultation and development sessions with key partners, the Northumberland children's and adults' safeguarding boards merged in April 2022 to become the integrated Northumberland Children and Adults Safeguarding Partnership. These new arrangements acknowledge that children and adult arrangements are underpinned by different legislation and statutory guidance, however, also recognise the similarities and shared benefits of a joint safeguarding approach across the life course.

The NCASP vision is to work together and provide added value across the safeguarding system, to improve practice and outcomes, and safeguard and promote the welfare of children, young people, adults, and their families in our community. A joint Executive and Partnership Board has ensured the Partnership continues to meet its statutory requirements, whilst a full review has been undertaken to ensure the needs of both partnerships are met, and any new arrangements are carefully planned and implemented.

The current parameters, themes and reporting arrangements of the current subgroups have recently been reviewed, and consideration has also been given to the supporting structure of NCASP and its alignment to wider Partnerships. This work has been overseen by a Lead Task and Finish group, comprising of multi-agency Partnership leads, and has reported regularly into the NCASP Executive group. We will invite one of the Partnership Business Partners to update schools on the changes at the Locality Briefings at the end of this half term.

It is important to remember that Ofsted Inspectors have been asking head teachers, designated safeguarding leads and safeguarding governors about their understanding of how the local partnership works and what the local priorities are, so it is important that you keep in touch with what is happening locally.

Currently schools are known as relevant partners of the safeguarding partnership.

### Northumbria Connected



Northumbria Connected is a new tool being promoted by Northumbria Police to ensure that they are delivering on the issues that affect all communities across the North East. Information on how to sign up has been saved in the 'police Information' folder on the DSL SharePoint Site and we ask you, as

partners of NCASP to share the information with the school community, including pupils, parents and staff. The resource in the folder can be downloaded and shared with everyone and gives clear instructions on how to register.

There is also a working group looking at the guidance for **Fabricated or Induced Illness/Perplexing Presentations.** We have requested that once the guidance has been redrafted that we share with a few schools for feedback, so we will keep you informed as that progresses.

**Virtual School Updates** 

#### **Suspensions and Missed Sessions**

As you know keeping our young people in school is a priority and we have had a timely reminder from Tara Prescott, the ESLAC Team Manager, in relation to the rising number of suspensions being given to looked after children.

We have significant concerns regarding the overuse of suspensions, and missed learning given the already fractured and disrupted learning that our looked after children have experienced prior to entering care. The primary reason used for suspensions is 'persistent disruptive behaviours', however when unpicking these, the majority are children in crisis and in a heightened state of dysregulation.

#### Suspensions are not an effective behaviour management strategy for looked after children:

- Safeguarding if they're not in school where are they and are they safe?
- Puts additional pressure on the foster placement or children's home.
- Increases lost learning for children who are already at a disadvantage academically.
- Triggers feelings of shame, rejection and loss for children who already carry this with them daily.
- Negatively impacts key relationships in school with adults and children.
- Coming back to school is yet another difficult transition for children who are already likely to be experiencing transition fatigue.
- Gaps widen between them and peers, limited educational progress.

#### Alternative to Suspensions:

- Key Adult in school
- Relational behaviour policy
- Trauma informed practice
- Emotion Coaching
- PACE
- Restorative Approaches
- Time In/Internal Suspension NOT isolation
- Time limited provision outside of school (AP/PRU etc)

#### Prevent

#### Martyn's Law

Following the Government's consultation on updates to the Protect Duty, which is part of the Prevent Duty, there is a plan to update guidance to schools and colleges in relation to security guidance for publicly accessible locations (PALs). The following summary from the interim guidance identifies some of the key points that will shortly be made available to schools.

Why do I need to consider counter-terrorism? The terrorist threat to education settings is currently assessed as low. Martyn's Law legislation will improve the security awareness and preparedness of a range of locations to protect against and mitigate the impact of attacks. Improving CT security awareness and preparedness mitigates against a range of risks – not just from terrorism. As Protect Duty policy develops, and as and when legislation is agreed by Parliament, tailored guidance will support the education sector to meet its obligations under the Protect Duty.

What resources can I access now? All schools will have policies, plans and procedures in place to deal effectively with health and safety responsibilities. Processes to identify, assess, and review health and safety

risks can be adapted to address security matters. Guidance, training and advice on safety and security can be found here:

• <u>ProtectUK</u> is a new counter terrorism Policing platform to help organisations counter terrorism, increase awareness and stay alert. The ProtectUK app offers actionable content that can help counter-terrorism. The app also includes videos, such as 'RUN HIDE TELL' showing clear steps to take if faced with a terrorist incident.

• <u>Centre for the Protection of National Infrastructure | CPNI</u> - As the UK Government's national technical authority for physical and personnel protective security, the CPNI website covers a range of advice and guidance that is free to access.

• <u>School and college security - GOV.UK (www.gov.uk)</u> is non-statutory guidance to help schools and colleges develop policies and plans to manage and respond to security related incidents. The local context is crucial when developing your policies. This should reflect your school or college's unique circumstances, including size and location, character and ethos, educational needs, and local priorities.

We are in regular contact with our colleagues in the counter terrorism team and will update you as the guidance develops and is made available for educational settings.

### Update from the Inclusion Team



Last term the inclusion team published their first Northumberland Strategic Inclusion Strategy which sets out how they will promote Inclusion and prevent exclusion. The strategy draws heavily from examples of the strong leadership and good practice that already exists in many Northumberland early years' settings, schools and Post 16 provisions, where there is robust evidence of strong inclusive

practice and a reduction in the use of exclusion.

This strategy is seen as the foundation on which Northumberland can now build upon a shared commitment to working in partnership with multi-agency services, schools, academies, early years and post 16 settings and the local authority.

Education settings and services should use this strategy to inform their policies, practice and multi-agency planning in their work to ensure good outcomes for our children and young people ensuring that promoting inclusion and preventing exclusion is everybody's responsibility in Northumberland.

# Change to the Law in Relation to the Legal Minimum Age for Marriage



The legal minimum age of marriage has increased to 18 in England and Wales under the Marriage and Civil Partnership (Minimum Age) Act (2022). Children could previously get married at the age of 16 or 17 with parental consent. This new act makes it an offence to pursue any activity for the purpose of causing a child to enter into a marriage prior to age 18. Previously, it was only illegal if coercion was used. Those found guilty of

arranging a child marriage can now face up to seven years imprisonment. These new changes are a huge step in protecting vulnerable children, linked to child exploitation, forced marriage and domestic abuse.

# **National Child Exploitation Awareness Raising Day 2023**



The 18<sup>th</sup> March 2023 is National Child Exploitation Day and the National Working Group have added a <u>number of free promotional resources</u> to their website, which can be used to promote this day. There are also <u>training</u> events on offer, including myth busting sessions. These myth busting

sessions cover useful information, including:

- what CSE is
- how children are targeted and groomed for the purpose of CSE
- signs that might indicate that a child is being groomed for CSE or is a victim of CSE
- how to respond to CSE to protect children and hold the abusers to account for the abuse and harm that they cause.

### **Updated Cyber Security Resources**



Schools have an increasing reliance on IT and online systems which makes cyber security an important consideration. The Cyber PROTECT network has produced this document for the education sector to help schools understand the information, resources and services available to improve their cyber security.

Resources are available on <u>the National Cyber Security Centre's dedicated website</u> and are designed to help schools improve their cyber security, as well as various other NCSC resources that will prove useful to the education sector.
